



Tax Refund Procedures 办理退税手续的方法 **免税手続きの**方法

- To qualify for a tax refund, single-day purchases of general products or consumable goods must be ¥5,000 or more (excl. tax). Receipts from eligible shops can be added together. \bullet For consumable goods (such as cosmetics, food products, etc.) and for totals of both standard products and consumable goods added together, purchase totals ranging from ¥5,000 to ¥500,000 (excl. tax) are eligible for tax refund.
