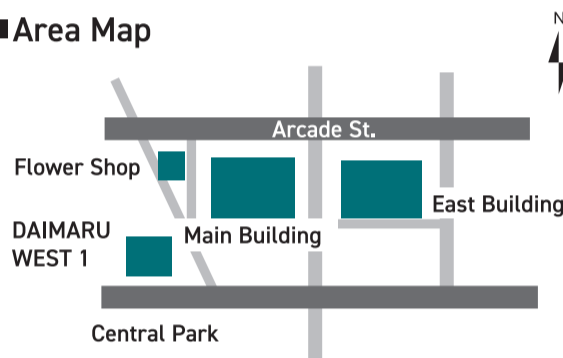

Person Who Made the Purchase 本人 ご本人	Applicant's Passport (Immigration Stamp Required) * Those returning to Japan temporarily must also present proof of their overseas status of residence, or a copy of their family registry. 护照 (入境印章) * 暂时回国时, 还须出示海外在留证明或户籍附票副本。 パスポート(入国スタンプが必要)※一時帰国の場合、海外在留証明または戸籍の附票の写しも必要。	Card Used for Purchase (If China UnionPay Card or Credit Card Was Used for Purchase) * Name on passport and card must be the same. 购物时持卡人 所持有的卡 (银行借记卡以及各种信用卡) * 护照和卡名义不一致时, 不能办理退税。 ご利用カード(銀聯カード、クレジットカードなどをご利用の場合)※パスポートとカードの名義が一致している必要があります。

Tax Refund Procedures

办理退税手续的方法 免税手続きの方法

● To qualify for a tax refund, single-day purchases of general products or consumable goods must be ¥5,000 or more (excl. tax). Receipts from eligible shops can be added together. ● For consumable goods (such as cosmetics, food products, etc.) and for totals of both standard products and consumable goods added together, purchase totals ranging from ¥5,000 to ¥500,000 (excl. tax) are eligible for tax refund.

● 一般商品和消耗品的购物金额分别满5,000日元(不含税)便可办理退税(适用店铺的购物收据可合并计算)。● 化妆品、食品等消耗品或一般商品与消耗品的合并购物金额5,000日元以上(不含税)以下可办理退税。

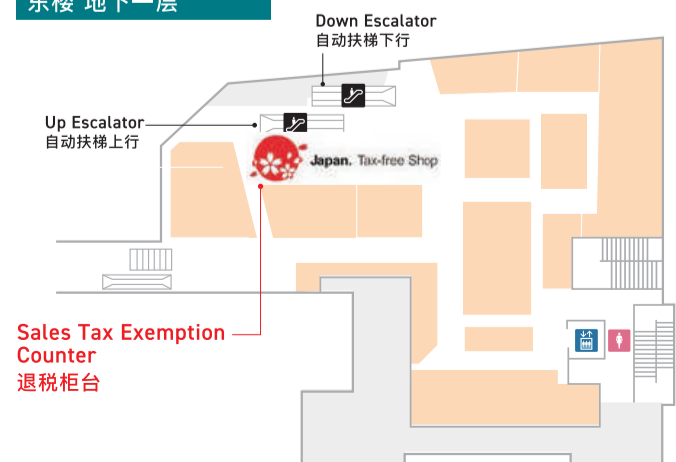
